Matters from Competitors and Drivers Briefing:

Stewards' Decisions – Penalties imposed

The Stewards imposed Fines of \$500 on the Driver of Car #18, Lee Holdsworth, and the Authorised Representative of Chasports Racing Pty Ltd for failure to attend the Competitors & Drivers Briefing.

STEWARDS SUMMARY OF JUDICIAL OUTCOMES

Stewards' Decisions – Penalties imposed

Following a post-race DRD investigation and an admission by Car #1, Jamie Whincup of a Breach of Schedule B2 Article 6.6 (failed to exit Pit Lane wholly within the fast lane) the Stewards imposed a Fine of \$1,000 with \$500 suspended until 31/12/18.

Matters from Race 19 Qualifying:

Deputy Race Director Incident Determinations

Following a report from WAU Racing Pty Ltd, it was alleged Car #15, Rick Kelly impeded Car #25 at Turn 5, the DRD determined the above Incident does not warrant being referred to the Stewards.

Stewards' Decisions – Penalties imposed

Following a report from Triple Eight Race Engineering the DRD investigated an alleged incident where Car #55, Chaz Mostert impeded Car #97, Shane van Gisbergen on the entry to Turn 6 and determined a Breach of Schedule B2 Article 2.1.1 – Careless Driving, the Stewards imposed a Three (3) Grid Spot Penalty for Car #55 in Race 19

Matter from previous event

Stewards' Decisions – Penalties imposed

The Stewards imposed a Fine of \$1000, with \$500 suspended until 31 December 2018, on Tekno Autosports for a breach of Supplementary Regulation 5.6 (Teams are not permitted to drain Driver's bath water at any time into the Paddock)
