1. Instructions on how to enter and prize information forms part of these Terms and Conditions. Participation in any competition is deemed as acceptance of these Terms and Conditions.
2. The promoter is V8 Supercars Australia Pty Ltd (ABN 94 077 053 484) of Level 34, 100 Miller Street, North Sydney NSW 2060) (Promoter).
3. Supercars standardly conducts two types of competition, games of skill or game of chance. In the case of game of skill, each entry will be individually judged based on its literary and creative merit. In the case of game of chance, winners are based on random selection.
4. When there is a game of chance competition, Supercars is authorised to conduct this competition without a licence as the prize is under \$3,000 AUD.
